NOTE: Applications will not be accepted prior to October 23 nor accepted after November 6.

Applications received by the above-mentioned deadline will be compiled and seasonal campers will be chosen by randomly drawing a name from those submitted applications. The number of applications (names) drawn will be equivalent to the number of vacancies in the upcoming camping season.

Using the table below, please indicate your preferred choice of lots, in order of preference (up to 5 sites may be selected). A map has been provided for your reference.

Obtaining a seasonal site

The draw for seasonal camping will be held on November 8<sup>th</sup>, 2023.

1. Names will be drawn randomly from the Applications submitted.
2. The first name (applicant) drawn will obtain their first preferred site indicated on their request form.
3. Additional names (applicants) will be drawn one at a time with each applicant given the opportunity to obtain their first preferred site, unless the site was assigned to the name previously drawn. Should the applicant’s first preferred site not be available, their second preferred site is offered (if available), and so on.
4. If the applicant is unsuccessful in obtaining any of their five preferred sites, they will be contacted and given the opportunity to choose another site in the park.
5. Names will continue to be drawn until the number of vacancies has been reached.

Following the draw for seasonal sites, individuals will be contacted to confirm their assigned site. New campers will be asked to complete the 2024 Seasonal Camping Agreement and return the first 3 pages back to our office, with a \$450 lot deposit, no later than Friday, November 17<sup>th</sup>, 2023. Should the 2024 Seasonal Camping Agreement and deposit not be received by the stated deadline, the RRCA will assume the individual has opted out of seasonal camping and the RRCA will offer the vacancy to another interested party.

If your consumption is lower than \$300.00 hydro deposit fee, you will receive a refund for the difference.
